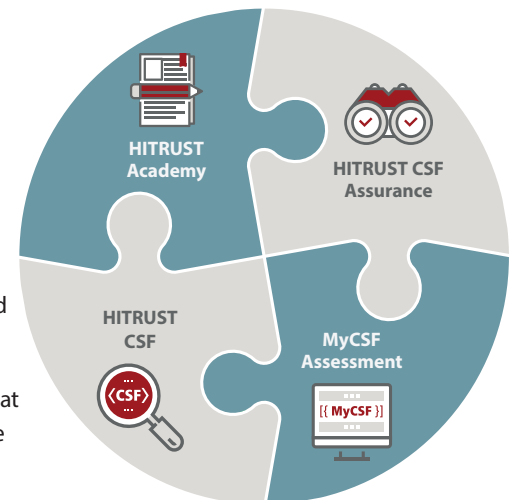

HITRUST CSF Assurance Methodology – The HITRUST CSF Assurance Program™ provides a simplified and consistent approach to assessments and reporting against the HITRUST CSF and any of the authoritative sources it incorporates. This risk-based assurance approach, which is governed and managed by HITRUST, is designed to address evolving information threats and unique regulatory and business needs of organizations while delivering an effective, standardized and streamlined assessment process for reporting compliance and information risk posture. Since the HITRUST CSF synthesizes numerous standards and frameworks into a single comprehensive and harmonized framework, it eliminates the need for multiple assessments or answering redundant assessment questions, an approach we refer to as Assess Once, Report Many™.
